2024-2025 Dining Plan Agreement

- _____ **Unlimited Dining Plan - \$2,575.00 per semester** - Allows you to enjoy unlimited entry at Regattas or The Commons as frequently as permitted during the serving hours. Includes \$100 in Dining Dollars each semester.

- _____ **14 Dining Plan - \$2,480.00 per semester** - Allows you to enjoy 14 meals per week at Regattas or The Commons. Includes \$150 per semester in Dining Dollars.

- _____ **10 Dining Plan - \$2,480.00 per semester** - Allows you to enjoy 10 meals per week at Regattas or The Commons. Includes \$250 per semester in Dining Dollars.

- _____ **80 Block Dining Plan - \$1,300.00 per semester** - Allows you to enjoy 80 meals each semester at Regattas or The Commons as frequently as permitted during the serving hours, until you have used all of the meals allotted to you. Includes \$200 per semester in Dining Dollars.

- _____ **No Dining Plan**

Dining Plan Requirements:

- Freshman students must select either a 14 or Unlimited dining plan.
- Upper-class students in suite-style units must select a 10, 14, or Unlimited dining plan.
- Residents in apartment-style units with a kitchen in the unit may select any dining plan option, including the No Dining Plan. Access to a community kitchen does not qualify students for the No Dining Plan option.
- Commuter students may select any dining plan option.

Dining plan changes must be received by 5pm on Friday during the first week of classes either semester. Dining plan changes are allowed between semesters (fall to spring).

If your dining plan includes Dining Dollars, \$50 is deposited for the first week of classes, and the remainder (if any) is added during the second week of classes each semester.

You must pay for the dining plan by the payment deadline or at the time you add/increase a dining plan whichever is later. Payments may be made online via CNU Live; by check mailed to the Cashier's Office; or in person at the Cashier's Office, Christopher Newport Hall, First Floor.

I have reviewed and understand the policies and restrictions that apply to the Dining Plan as described in the Housing & Dining Services Contract. I am also aware that the length of the agreement is for ONE ACADEMIC year. No credit adjustment or refunds will be given for missed meals or unused Dining Dollars.
