

Day 1: Wednesday, July 29, 2026 Fairbanks, Alaska Arrive today in Fairbanks, in the great state of Alaska, on an adventure that brings together the best of both land and sea. As traveler's arrival times vary greatly, we have no group activities planned during the day.

Day 2: Thursday, July 30, 2026 Fairbanks - Denali National Park Step aboard the popular Sternwheeler Discovery, an unforgettable journey showcasing Alaska's diverse culture and rich history. Make stops along the way to meet the people and get a taste of local life. Take a scenic motor coach ride to Denali National Park. Tonight, enjoy a musical performance that tells the story of the first brave men to summit Denali followed by dinner. (*B, L, D*)

Day 3: Friday, July 31, 2026 Denali National Park This morning, travel deep into Denali National Park on the Tundra Wilderness Tour* which affords the best opportunities to view the region's wildlife. Learn about the history of the park and see why Denali is one of the top three reasons that people visit Alaska. The remainder of the day is at leisure. (B)

Day 4: Saturday, August 1, 2026 Denali National Park - Talkeetna Your day begins with a scenic train ride to Talkeetna. Savor every moment inside your luxury domed railcar. View the incredible landscape from glass-ceiling railcars and open-air observation platforms as rail guides provide expert commentary. Check into the iconic Talkeetna Alaskan Lodge, perched on a ridge offering unforgettable views of Denali. (B)

Day 5: Sunday, August 2, 2026 Talkeetna - Anchorage - Whittier - Board Cruise Ship Depart for your ship, stopping en route in Anchorage, Alaska's largest city. Continue with a scenic drive along the Chugach Mountains. Drive along the Turnagain Arm to the Alaska Wildlife Conservation Center. Discover where orphaned or injured bears, wolves, porcupines, and moose are cared for in a 200-acre rehabilitation site. Arrive in the port of Whittier where you'll embark on your 7-night Holland America cruise aboard a fabulous floating resort designed to make your stay on board truly memorable. You will be dazzled by the entertainment in the state-of-the-art lounges and a myriad of dining options. While on board, breakfast, lunch, dinner and nightly entertainment are included. (B, D)

Day 10: Friday, August 7, 2026 Cruising - Ketchikan Your port of call today is Ketchikan, known as the "Salmon Capital of the World" and the "City of Totems." Located on the tranquil Revillagigedo Island, Ketchikan is home to the world's largest collection of totem poles. (B, L, D)

Day 11: Saturday, August 8, 2026 Cruising - Inside Passage A wonderful day of sightseeing awaits as your ship sails along the amazing Inside Passage. (B, L, D)

The overall activity level of this tour is a level 1. This means you're a leisurely traveler. Experience It! Denali National Park

In 1917, Alaska named its first national park Mount McKinley National Park and nearly 70 years later the park was expanded and renamed Denali National Park. This vast land has a fascinating ecosystem and is more than a park — it is a wildlife reserve. And perhaps its biggest claim to fame is being the home to North America's highest peak, Denali, ascending more than 20,000 feet. This massive park is now more than 6 million acres, an area that can be compared to the size of Massachusetts. The park is home to nearly forty different varieties of mammals, but the most popular residents are moose, caribou, wolves, plus brown and grizzly bears. Denali is Alaska's heartland and brings you up close to its majestic beauty and natural wonders.

To complete your tour, we <u>include</u> roundtrip airport-to-hotel transfers when purchasing our airfare with your tour. If you have arranged for your <u>own air</u>, we are pleased to provide you the option of *purchasing* these transfers. Please note that all transfers will leave at pre-scheduled times.

Onboard gratuities are not included in the price of your tour. For your convenience, Holland America Cruise Lines automatically applies a \$17.00 USD (quoted at time of printing) per traveler per day service charge to your shipboard account. If you upgrade to a suite, the gratuities increase to \$18.50 USD per traveler per day. This service charge covers all onboard service personnel, so no additional tipping is necessary. Most flights arrive into Fairbanks very late at night followed by an early morning the next day.

For air-inclusive reservations, the name provided at time of booking must match your government-issued ID that will be used during travel. Name changes are subject to penalties.

Please be advised many airlines do not provide advance seat assignments until check-in at the airport. Advance seating will be subject to the airline's terms and conditions.

Due to tour scheduling, return flights should not be booked prior to 12:00 noon

Prior to full payment for the program, the cruise line reserves the right to impose a supplemental fuel charge. Should this occur, you will be notified of the additional charges.

Taxes and fees starting from \$715 USD per person, quoted at time of reservation, are included in the tour cost. Single cabins, if confirmed, are higher.

IDENTIFICATION

Travel within USA

For travel completed by May 6, 2025, all airlines will ask for identification when you check in. It is recommended that you carry a passport if you have one. A driver's license (with a photo I.D.) is also acceptable for domestic flights.

Effective for travel May 7, 2025 forward, the REAL ID Act standards for identification while travelling will be in effect. This means a standard issued driver's license used as a form of identification will no longer be accepted for domestic air travel within the United States. Instead, a Real ID compliant form of identification must be presented both at the time of booking air travel with Collette and upon checking in at the airport to board any flight. Any fees associated with changing a reservation resulting from a non-compliant identification will be the responsibility of the guest.
